PUBLIC DEFENDER

Since the passage of Prop 47, county Public Defenders' offices have sought to provide legal assistance to currently incarcerated people with Prop 47-eligible convictions. Public Defenders may also be able to provide legal assistance to formerly incarcerated people seeking to reduce their convictions under Prop 47. CLEAN SLATE CLINICS

California provides some mechanisms for the restoration of rights for formerly incarcerated or convicted people. One of these mechanisms is the "set-aside and dismissal" procedure,¹ or is often called "expungement" or "clean slate."² The following agencies and organizations provide assistance with "clean slate" record remedies.

LIVESCAN PROVIDERS

The first step to getting a record reduction under Prop 47, an “expungement,” or any other record relief is to obtain your RAP sheet (“record of arrests and prosecutions”). To do so, complete a Department of Justice (DOJ) Record Request Form, pay the \$25 DOJ fee or submit a fee waiver request, and get your fingerprints taken at a Live Scan location (see below).
